A BILL

To require certain actions related to resettlement of certain Afghan and Iraqi special immigrants, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Afghan and Iraqi Allies
5 Resettlement Improvement Act”.

6 **SEC. 2. SURVEY ON LONG-TERM OUTCOMES FOR CERTAIN**
7 **AFGHAN AND IRAQI SPECIAL IMMIGRANTS.**

8 (a) IN GENERAL.—The Secretary of Health and
9 Human Services, in conducting the next Annual Survey

1 of Refugees pursuant to section 413(b)(1) of the Immigra-
2 tion and Nationality Act (8 U.S.C. 1523(b)(1)), shall con-
3 duct a supplement to examine and report on long-term
4 outcomes for the special population described in sub-
5 section (b), including employment, job security, wage
6 growth, career advancement, housing, home ownership,
7 and educational attainment.

8 (b) POPULATION DESCRIBED.—The special popu-
9 lation described in this subsection is the cohort of individ-
10 uals who were admitted into the United States as a special
11 immigrant under one of the applicable provisions of law
12 within the five-fiscal-year period immediately preceding
13 the fiscal year in which the supplement is conducted.

14 **SEC. 3. IMPROVED DELIVERY OF INFORMATION ABOUT RE-**
15 **SETTLEMENT TO PROSPECTIVE AFGHAN AND**
16 **IRAQI SPECIAL IMMIGRANTS.**

17 (a) IN GENERAL.—The Secretary of State shall iden-
18 tify and implement additional ways to deliver information
19 in Dari, Pashto, or Urdu to prospective SIV holders about
20 the United States resettlement program to assist with
21 post-arrival adjustment and expectations, including more
22 detailed or in-depth information on key issues. The Sec-
23 retary shall also identify and address potential gaps in dis-
24 seminating relevant information to SIV holders, such as
25 at embassies and online.

1 (b) DEFINITION.—For purposes of subsection (a),
2 the term “prospective SIV holder” means an alien who
3 has applied, or is considering applying, for admission into
4 the United States as a special immigrant under one of
5 the applicable provisions of law.

6 **SEC. 4. EMPLOYMENT FOR RESETTLED AFGHAN AND IRAQI**
7 **SPECIAL IMMIGRANTS .**

8 (a) IN GENERAL.—Not later than 90 days after the
9 date of the enactment of this Act, the Secretary of Defense
10 and the Secretary of State shall jointly establish and oper-
11 ate a temporary program to offer employment as trans-
12 lators, interpreters, or cultural awareness instructors to
13 individuals described in subsection (b).

14 (b) ELIGIBILITY.—Individuals referred to in sub-
15 section (a) are individuals who were admitted into the
16 United States as a special immigrant under one of the
17 applicable provisions of law.

18 (c) FUNDING.—

19 (1) IN GENERAL.—Except as provided in para-
20 graph (2), the program established under subsection
21 (a) shall be funded from the annual general oper-
22 ating budget of the Department of Defense.

23 (2) EXCEPTION.—The Secretary of State shall
24 reimburse the Department of Defense for any costs

1 associated with individuals described in subsection
2 (b) whose work was for the Department of State.

3 (d) **RULE OF CONSTRUCTION REGARDING ACCESS TO**
4 **CLASSIFIED INFORMATION.**—Nothing in this section may
5 be construed as affecting in any manner practices and pro-
6 cedures regarding the handling of or access to classified
7 information.

8 (e) **INFORMATION SHARING.**—The Secretary of De-
9 fense and the Secretary of State shall work with the Sec-
10 retary of Homeland Security, the Office of Refugee Reset-
11 tlement of the Department of Health and Human Serv-
12 ices, and nongovernmental organizations to ensure that in-
13 dividuals described in subsection (b) are informed of the
14 program established under subsection (a).

15 (f) **REGULATIONS.**—The Secretary of Defense, in co-
16 ordination with the Secretary of State, shall prescribe such
17 regulations as are necessary to carry out the program es-
18 tablished under subsection (a), including establishing pay
19 scales and hiring procedures, and determining the number
20 of positions required to be filled.

21 (g) **TERMINATION.**—The program established under
22 subsection (a) shall terminate on December 31, 2026.

23 **SEC. 5. DEFINITION.**

24 For purposes of this Act, the term “applicable provi-
25 sions of law” means the following:

1 (1) Section 1059 of the National Defense Au-
2 thorization Act for Fiscal Year 2006 (Public Law
3 109–163; 8 U.S.C. 1101 note).

4 (2) Section 1244 of the Refugee Crisis in Iraq
5 Act of 2007 (8 U.S.C. 1157 note).

6 (3) Section 602 of the Afghan Allies Protection
7 Act of 2009 (8 U.S.C. 1101 note).
